## Now is the time to ACT! Tell Congress to avoid cuts to science funding TODAY!

As you probably know, America is rapidly approaching the so called “fiscal cliff” – a devastating combination of across-the-board budget cuts, known as sequestration, and a series of tax increases. **Sequestration cuts mean less funding for government agencies that support research**, like the National Science Foundation and the National Institute of Food and Agriculture. Less funding means fewer grants, lab closures and layoffs. We cannot let this occur.

As we speak, Washington leaders are trying to work out a debt deal that will avoid the fiscal cliff and put America on a path to economic sustainability. While it may be hard to believe, it’s possible **that a plan to avoid sequestration could actually be worse for science funding agencies** than sequestration itself.

Because of this, we’re asking all ASA, CSSA and SSSA members to reach out to their Congressional delegation TODAY and urge them to craft a comprehensive deficit reduction plan that **does not include further cuts to science, technology and research programs**. Join with hundreds of other national, state and local organizations on this “Day of Action” where the research community is letting Congress know that further cuts to science funding will compromise our nation’s security, global competitiveness and economic growth.

They are hosting the “[Don’t Let Science Go Over the Fiscal Cliff](#)” campaign, which asks Congress to avoid further cuts to science funding. Once you create an advocacy account, you can sign a petition from the research community and easily email, message and tweet to your Congressional delegation.
